- "Customer" shall mean the Customer or any person acting on behalf of and with the authority of the Customer
- "Guarantor" means that person (or persons), or entity who agrees herein to be liable for the ustomer on a principal debtor basis.
  "Services" shall mean all services supplied by the Seller to the Customer and includes any
- advice recommendations. "Price" shall mean the cost of the Services as agreed between the Seller and the Customer clause 4 of this contract.

- Acceptance
  Any instructions received by the Seller from the Customer for the supply of Services and/or the Customer's acceptance Services supplied by the Seller shall constitute acceptance of the terms and conditions contained herein
- Where more than one Customer has entered into this agreement, the Customer's shall be verally liable for all payments of the Price.

#### Default & Consequences Of Default
